What's the Impact?

\$1,000 could provide 100 books for independent reading

\$5,000 could provide a year-long service project for an entire grade

\$10,000 could provide de-escalation spaces for kids dealing with trauma

\$25,000 could provide a middle school athletics program at one school

\$50,000 could provide instruments and staffing to establish a concert band at one school

Educational & Opportunity Pennsylvania Tax Credit Programs (EITC & OSTC)

EITC/OSTC tax credit programs offered by the state of Pennsylvania provide your company tax credits which can equal 75%-90% (depending on a 1 or 2 year commitment) of your contribution up to a maximum of \$750,000 per taxable year.

- Mastery Charter Schools Foundation is approved to receive OSTC and EITC-EIO (Educational Improvement Organization) donations. Programs supported by EITC-EIO funds at Mastery include: STEM, K-2 Literacy, Internship program, and College Dual Enrollment.

Please speak with your CFO or accountant to determine if you are already a participant and could select Mastery as a recipient, or if your company is eligible to apply. Most C-Corp, S-Corp, Multi or Single Member LLCs doing business in PA are eligible! We are happy to help with the application process for this tax credit.
