Background: In 2016 the Board adopted a Nondiscrimination / Affirmative Action Policy to bring us into compliance with regulations and to satisfy the requirements of the Comprehensive Equity Plan (CEP) that we submitted in 2016. In 2019 we submitted an updated CEP and NJDOE returned it with feedback that our Board policies were not explicit enough on a number of topics. After conversations with NJDOE, it is recommended that we add some clarifying language to our existing Nondiscrimination / Affirmative Action Policy in order to meet NJDOE expectations.
