RESOLUTION REGARDING PAYROLL PROTECTION PROGRAM LOAN FORGIVENESS APPLICATION

WHEREAS, the Mastery Schools of Camden, Inc. ("School") is a duly authorized 501(c)(3) organization; and

WHEREAS, the mission and purpose of the School is to improve the educational outcomes of its students and advance the interests of its other stakeholders and greater community; and

WHEREAS, there had existed economic uncertainty regarding the funding necessary to support the ongoing operations of the School; and

WHEREAS, such uncertainty related to the School's questionable funding status from student residences, a new legislative mandate to continue staffing wage and benefit levels and certain vendor contracts through this year, and public statements by the Governor and other state officials, including references to the substantial risk of laying off school staff due to budgetary distress; and

WHEREAS, the School's Board of Trustees at all times desires to take fiscally prudent measures in accordance with the School's mission and the law; and

WHEREAS, the School's Board of Trustees at its April 21, 2020 meeting ratified the submission of an application for certain loan financing available under the federal CARES Act's Payroll Protection Program ("PPP"); and

WHEREAS, the PPP loan application was duly approved, and proceeds released ("Loan Financing"); and

WHEREAS, the PPP provides for the forgiveness of the Loan Financing upon the satisfaction of certain defined conditions, including (a) the Loan Financing has been expended only for costs that are eligible for forgiveness in accordance with legal requirements set forth in the PPP; (b) payroll costs constitute at least 60% of the amount sought to be forgiven; (c) the School has not knowingly used the Loan Financing for an unauthorized purpose; and (d) the School can accurately verify the expenditures for which loan forgiveness is being sought; and WHEREAS, the School's Administration has duly verified the School's compliance with the forgoing conditions for the forgiveness of the Loan Financing. NOW THEREFORE BE IT RESOLVED, that the School's Board of Trustees be and hereby approves the submission of the PPP loan forgiveness application; and

BE IT FURTHER RESOLVED that Yonca Agatan, Chris Barts and Suzanne McKenna are hereby authorized, empowered and directed to execute and deliver any documents, certificates, agreements and instruments concerning an application for forgiveness of said PPP Loan Financing.
