- Presentations on attendance, engagement and RP2 results. Board members requested that management measure engagement and continue to give updates throughout the year.
- CEO shared that the first round of staff testing has begun with over 1,100 tests administered with a very low positivity rate. Vaccine scheduling has begun. HVAC/Ventilation work will be completed and each school has completed a 47 point operational readiness checklist evaluation. COVID rates are declining.
- CEO asked board to approve an adjustment to the Assistant Principal salary scale and create a standard salary scale for all Assistant Principals —this is in order to recognize the tremendous work the Assistant Principals of Operations have done, before and during the pandemic. (R-210217-06a,b)
- Next challenge will be the simultaneous teaching model.
