The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Mastery Charter Schools has committed itself to pay certain self-funded Medical and Dental claims incurred under the terms of the plan.

The plan has contracts with Cigna Health and Life Insurance Company, Reliance Standard Life Insurance Company and Vision Service Plan to pay Vision, Life Insurance, Accidental Death and Dismemberment, Short-Term Disability, Long-Term Disability, Voluntary Critical Illness, Accidental Injury, Voluntary Hospital Care and Employee Assistance Program claims incurred under the terms of the plan. The total premiums paid for the plan year ending June 30, 2022 were \$1,446,625.
