# **High School Attendance Policy Revision (Saliyah Cruz)**

Background: We are revising our attendance policy for high school students in order to establish clear attendance expectations (aligned to our current excessive absence policy outlined in the board approved SY24 Student-Parent Handbook) for earning course credits in high school. The new policy is:

Students who are absent (excused or unexcused) more than 8 periods for a specific course within a report period will automatically receive a failing grade of 50 for that course for that report period.

Students who are absent (excused or unexcused) more than 35 periods for a specific course within the year will automatically receive a failing grade of 50 for that course for the school year.
