## R-231206-6 (Pickett Board Only)

**Resolved**, by the Board of Mastery Charter School - Pickett Campus relating to the construction costs of the Sports Field Project (the "Project").

**WHEREAS**, the Mastery Charter School - Pickett Campus has heretofore received an award letter from the Commonwealth of Pennsylvania ("Commonwealth") announcing a \$500,000 grant from the Redevelopment Assistance Capital Program to pay a portion of the construction costs of the Project ("RACP Grant"); and

**WHEREAS**, the Mastery Charter School - Pickett Campus has and continues to have on hand in its Firstrust Bank Account ending in 3091 funds of \$4,129,000 which, are sufficient to cover Matching Funds of \$3,125,000 to cover the cost of the RACP Project; and

**WHEREAS**, as funds are and have been required, such funds were and are used to pay the invoices for the construction costs of the Project.

**NOW THEREFORE,** be it resolved by the Board of the Mastery Charter School - Pickett Campus as follows:

- The Board hereby authorizes, approves and ratifies and confirms that (i) the construction cost of the Project is \$3,625,000, and the Mastery Charter School - Pickett Campus has on hand sufficient funds to complete the Project; (ii) the Mastery Charter School - Pickett Campus has on hand sufficient matching funds for the RACP Grant Matching Funds of \$3,125,000 in the Firstrust Bank Account ending in 3091 committed and secured for the RACP Project as required by Commonwealth law and regulations; and such funds are available to pay the construction, as the invoices of have been and are posted for the Project.
- 2. The management of the Mastery Charter School Pickett Campus, and Mastery Schools' Chief Operating Officer, Chief Financial Officer and Senior Director of Facilities are hereby authorized and directed, jointly and severally, to carry out the provisions of this Resolution and to execute such documents and take such actions as are necessary and appropriate to effectuate the Project and comply with the requirements of the RACP Grant.
- 3. This Resolution shall take effect immediately on adoption this 6<sup>th</sup> day of December 2023
