# Legal Update (Tom Johnston)

Additional Discussion:

- Counselor Johnston updated the members on the five-year case of Latino Action Network vs. the State of New Jersey. He talked about how the October court date opened the door to advocate for our Renaissance schools to potentially be funded for students that reside out of the Camden City jurisdiction.
- Mr. Sheward inquired about Mastery's position in terms of mediation and the feasibility of being part of the conversation. Legal Counsel discussed the matter to the members' satisfaction.
- Mr. Reynolds asked Counselor Johnson if he was able to foresee the outcome of the fiveyear litigation and if he thought that the current residency restriction would potentially be eradicated. Counselor Johnson stated he doesn't foresee all residence restrictions being eliminated however, he can see the school choice opportunity to be enhanced.
