Management expressed confidence that the proposed salary scale adjustment will be competitive for PA teachers and that they would continue to monitor the District proposal as more details emerge.
- Mr. Sheward asked if the salary scale adjustment has any negative impact on the budget. Management stated that the recommended salary scale adjustments aligned with budget assumptions for next year and that they will be monitoring and adjusting as need it.
