# V. Finance Report (Dan Bell)

• Overview of September Financials

#### Discussion:

- Bob Victor inquired about the \$2 million positive variance in Other Revenues.
- Dan Bell explained that the positive variance was driven by higher earnings than budgeted on investment of cash reserves.
- Judith Tschirgi asked about the reserves for the food service program.
- Dan Bell explained that the federal food service program can generate an annual surplus to be reinvested back in the program for maintenance and repairs, new equipment and as a safety net for food cost increases.

### **Discussion:**

- Bob Victor asked about the core goals for Mastery students' success after graduation, emphasizing functional literacy and basic math skills like algebra as minimum standards. He questioned whether existing exams, such as the Keystone exams, effectively measure these skills and whether meeting Pennsylvania's proficiency levels align with Mastery's mission.
- Jeff Pestrak and Jessica Varevice affirmed that the Keystone exams are reasonable benchmarks for assessing reading comprehension and algebra readiness. They acknowledge areas where performance in science and math is lacking, noting Plan 2029's emphasis on post-secondary readiness and STEM, given the higher wage

potential in STEM careers.

- Joel Boyd and others discussed the ambitious goal of 100% proficiency, acknowledging the challenges posed by student mobility and differing starting points.
- Saliyah Cruz highlighted the promotion strategy to ensure foundational skills early on, preventing students from advancing with significant gaps.
- Markida Ross emphasized that students' success depends on parent engagement, highlighting the efforts of the parent action team in supporting the community and encouraging other parents.
- Joel Boyd acknowledged the importance of family involvement.
- Dee Dukes asked if special education students are included in the high expectations and curriculum plan.
- Jessica Varevice confirmed special education is a priority in the strategic plan, beginning with an audit of current offerings. A three-year improvement plan will follow, ensuring students with IEPs are supported for growth.
- Dee Dukes praised the programs and inquired whether there are any academic requirements for recruitment into Hardy High's healthcare program.
- Saliyah Cruz shared that Hardy High's healthcare program has no academic prerequisites and is open to all interested students. Half come from Hardy Middle School, while others are from city options. The program starts providing healthcare exposure in middle school, helping students make informed decisions by 11th grade.
